The board of education held the regular monthly meeting on Monday, November 9, 2020, 6:00 PM at the MS/HS cafeteria. Members present: Glenn Herrman, Bruce Kershner, Aaron McGaughey, Sandy Showalter, Harland Werth and John Irvin. Also Superintendent Keeley, Deputy Clerk Renfrow, Principal Webster, Kim Peach and Melissa Romme were present.

President Irvin opened the meeting at 6:00 PM. Aaron McGaughey moved, seconded by Sandy Showalter to approve the printed agenda, with no changes or additions. Motion carried unanimously. 6-0

Glen Herrman moved, seconded by Bruce Kershner to approve by consent items in the agenda listed as A & B. Motion carried unanimously. 6-0

- Peach Kim Peach requested the use of the MS/HS kitchen to cook and distribute the Community Christmas Dinner on December 24<sup>th</sup> and 25<sup>th</sup>.
- Audit Melissa Romme, representing the audit firm Adams Brown presented the 2019-20 Financial Audit. No violations were found. The board will approve the audit at the next monthly meeting.
- Holopirek Rob Holopirek requested use of USD 395 facilities for 4<sup>th</sup> and 6<sup>th</sup> grade boys basketball practice. Harland Werth moved, seconded by Sandy Showalter to allow the 4<sup>th</sup> & 6<sup>th</sup> grade boys along with their coaches to use the facilities as long as all parties follow the current building and COVID cleaning procedures. 'Hold Harmless' agreements must be signed. Motion carried 6-0.
- Athletic Director, Rob Holopirek presented information concerning basketball game attendance sizes during COVID.  
Glenn Herrman moved, seconded by Aaron McGaughey to allow administration to work on the maximum seating capacity during COVID. Motion carried unanimously. 6-0.
- MS Girls BB Uniforms Discussion was held concerning Girls MS basketball uniforms.
- Peach Glenn Herrman moved, seconded by Sandy Showalter to approve Kim Peach the use of the school kitchen for cooking and distributing (carry out) Christmas dinner. COVID restrictions concerning # of people and sanitizing after use shall be followed. Motion carried unanimously. 6-0
- DO Wall Discussion was held concerning best procedure to repair leaks in the district office.
- HS BB Coach John Irvin moved, seconded by Harland Werth to approve Rick Keltner as the Assistant Boys High School basketball coach. Meeting carried unanimously. 6-0
- Lg Boiler Glenn Herrman moved the board approve the bills to American Boiler Inc. for the repair of the large boiler at the MS/HS. Motion carried unanimously. 6-0
